

# *Konocti Bay Sailing Club*

## 2010 Konocti Cup plus Half Cup

### Notice Of Race

#### **Event**

This event is the 26th annual Konocti Cup sailed on beautiful Clear Lake, California. This event will start at approximately 1030 hours on April 24, 2010. The Full Cup course is a 26 mile marathon race and the Half Cup course is 13 miles in length. The race headquarters is located at:

#### **Divisions**

The Full Cup will be divided into 2 divisions. **Division A** will be raced by all boats with a Nor Cal PHRF rating of **150** or less. **Division B** will be raced by all boats with a Nor Cal PHRF rating of **151** or more.

The Half Cup will be raced by all boats with a Nor Cal PHRF rating of **211** or more but all Monohull boats, regardless of their rating may race in the FullCup

A separate division is open to sailing **Multihulls** that have a valid Bay Area Multihull Association (BAMA) rating. This division can be expanded to a twice around Konocti Cup.

A minimum of 5 yachts and a consensus among them regarding applicable One-design class rules are needed to form a **One-design** division. To qualify as a one-design division, entries must be received prior to the deadline date of April 24, 2010. Final division assignments will be made on April 24, 2010. Final cutoff date is April 24, 2010 at 0800 hours.

#### **Waivers**

Prior to the start, the skipper of each entrant shall sign and file with the Organizing Authority, the Konocti Bay Sailing Club Liability Release Form which is found on the application form for this event.

### ***Rules***

This event will be governed by 2009-2012 Racing Rules of Sailing, County of Lake Boating Law, Sailing Instructions for this event, and any applicable Federal and State laws.

Operating VHF radios are **required**. They must be monitored during the race for safety.

All participants will be **required** to wear a lifejacket or approved floatation device during this event.

### ***Qualified Entrants***

This event is open to all keel and center board boats 19 feet and over with a valid San Francisco Bay or Konocti Bay Sailing Club PHRF certificate. In the event that identical boats rate differently under the two systems, the race committee shall assign a common number. Yachts without certificates will have a rating assigned by the race committee. A final handicap decision rests with the race committee.

Mandatory skippers meeting is at the sailing headquarters –Buckingham Clubhouse – April 24, 2010 at 0815 hours.

### ***Entry Fees***

The entry fee is \$50. United States Sailing Association members may deduct \$5. A late fee of \$10 will be charged for all entries received after 2400 hours April 15, 2010. Final entries close at 0800 hours on April 24th, 2010.

### ***Sailing Instructions***

The Sailing Instructions will be available at the Buckingham Clubhouse on April 24, 2010. Information will also be available on the web at <http://www.kbsail.com>

### ***Prizes***

Prizes will be distributed at Sunday morning awards brunch, April 25, 2010 at 0900 hours – Buckingham Clubhouse. All monohull boats are eligible for the first to finish and their division trophies per original Konocti Cup Deed. The first three places in each division and overall will be awarded prizes. Overall trophy will be based on corrected fleet time. Only monohulled boats are eligible for the overall trophy - Konocti Cup. Multihull boats receive a first to finish and corrected time division trophies. Multihull overall corrected will receive the Konocti Bay Trophy.

### ***Assignment to Division***

Division formation will be based upon the number and types of entrants. All divisions will be scored on basis of Time-on-Time. One-Design divisions will be allowed, upon request, by at least five (5) boats provided entries are received prior to the deadline date of April 24, 2010. Final division assignments will be made on April 24th, 2010. Final Cutoff date is April 24, 2010 at 0800 hours.
